GIFT AID EXPLAINED

Rules since April 2002 mean that a charity can reclaim tax on any donation if a donor is a taxpayer and signs a Declaration Form. It does not cost you any more but it assists greatly. All you need to do is sign the declaration below. To enable the charity to reclaim the tax on your donation, you must pay income tax or capital gains tax which at least equals tax reclaimed in the tax year. Higher rate tax payers can claim further tax relief in their Self Assessment tax return.

If your circumstance change or you are unsure whether your donations qualify for Gift Aid, contact the Treasurer at treasurer@ongarmusicclub.org.uk or get leaflet IR113 from your local tax office. You can cancel this declaration at any time by notifying the Treasurer.
